In the ongoing effort to realize our Vision and Mission, as expressed by our Schoolwide Learning Outcomes (SLOs) and Global Competencies, Yangon Academy International School and its stakeholders have collaborated since the 2021-22 school year to develop this Strategic Action Plan for School Improvement. The resulting Five Goals and accompanying Twelve Tasks* outlined within this document were driven by an essential question:

How can Yangon Academy International School better meet the 21st Century global-learning needs of its students, within a healthy and safe school culture?

To answer this question, the School community reflected methodically and deeply upon its school purpose, collected and analyzed varied forms of data, sought targeted input from all stakeholders, and learned from other experts in the field of international schooling. This document, therefore, with its focus on measurable goals and data-informed decisions, should be viewed not only as a road map for our school's renewal and improvement, but also as a beacon of inspiration for all stakeholders, symbolizing our unity, collaboration, and commitment to the constant pursuit of promoting in all students the development of healthy habits, the dispositions of responsible global citizenship, and the achievement of academic excellence.

Each task must...

- 1. Contribute to the comprehensive learning, development, safety, and/or well-being needs of all students.
- 2. Be preceded by, and/or accompanied by, appropriate Professional Development.
- 3. Be communicated to all stakeholders.
- 4. Include a plan to evaluate its effectiveness, post-implementation.
- 5. Have sufficient resources available and ample time allocated for effective implementation.
